## Centerfield Capital Partners Completes Record Year of Investment Activity

Indianapolis, IN – Centerfield Capital Partners announced today that 2007 was a record year of investment activity for the firm. Centerfield deployed \$22 million in five companies in 2007, and began investing their second fund, Centerfield Capital Partners II, L.P. New additions to the Centerfield portfolio included the following companies: Standard Locknut, LLC, A&D Environmental Services, Inc., Roehm Marine, LLC, Thermafiber, Inc. and SCT, Inc. Three of the firm's new investments were in Indiana-based companies.

In addition to the new investments, Centerfield also added three new professionals to the firm's team, expanding the number of total professionals to seven. Centerfield also successfully exited its interest in two companies – DCL Medical Laboratories, Inc. and Bil-Jax Corporation.
